

AGREEMENT

Terms of Service

The agreement between Rally and the organizations and people who use our workspace, task, and messaging product.

These Terms of Service ("Terms") govern access to and use of Rally (the "Service"), operated by Rally ("Rally," "we," "us," or "our"). By creating an account, accepting a workspace invitation, or otherwise using the Service, you agree to these Terms on behalf of yourself and, if applicable, the organization you represent (the "Customer").

01 — Accounts

Accounts and access

Access to the Service is invite-only. A workspace's Owner or an Admin invites people as Admins, Members, or Guests, and each role's access is scoped as described in the Service — Guests only see the lists explicitly shared with them, and Members only see the spaces they've been added to. You are responsible for keeping your login credentials confidential and for all activity under your account.

02 — Acceptable use

Acceptable use

You agree not to:

- Use the Service to store or transmit unlawful, infringing, or malicious content.
- Attempt to access data, workspaces, or accounts you are not authorized to access, or circumvent the Service's role and permission controls.
- Interfere with or disrupt the integrity or performance of the Service, including by probing, scanning, or testing its security without authorization.
- Reverse-engineer the Service except to the extent applicable law expressly permits.

03 — Customer content

Your content

You and your workspace retain ownership of the tasks, comments, messages, files, and other content you submit to the Service ("Customer Content"). You grant Rally a limited license to host, store, transmit, and display Customer Content solely to provide and support the Service. You are responsible for having the rights needed to submit your Customer Content and for its accuracy and legality.

04 — Availability

Service availability

We aim to keep the Service reliably available but do not guarantee uninterrupted access. We may suspend or restrict access for maintenance, security, or to comply with law, and we will make reasonable efforts to minimize disruption and provide notice where practical.

05 — Termination

Suspension and termination

A workspace Owner may stop using the Service, or remove any member's access, at any time. We may suspend or terminate access to the Service for any account or workspace that violates these Terms, poses a security risk, or where required by law. Upon termination, your right to access the Service ends, though we may retain data for a reasonable period as described in our Privacy Policy.

06 — Disclaimers

Disclaimers

The Service is provided "as is" and "as available," without warranties of any kind, whether express, implied, or statutory, including implied warranties of merchantability, fitness for a particular purpose, and non-infringement, to the fullest extent permitted by law.

07 — Liability

Limitation of liability

To the fullest extent permitted by law, Rally will not be liable for any indirect, incidental, special, consequential, or punitive damages, or any loss of profits, data, or goodwill, arising from or related to your use of the Service, even if advised of the possibility of such damages. Our total liability for any claim arising from these Terms or the Service is limited to the amount you paid us, if any, in the twelve months preceding the claim.

08 — Changes

Changes to the Service or these Terms

We may update these Terms from time to time. If we make material changes, we will notify workspace Owners by email and update the effective date above. Continued use of the Service after changes take effect constitutes acceptance of the revised Terms.

09 — Governing law
